THE PARISH WEEKEND

On Friday, January 21, about 23 members of the parish assembled at Stoke Poges to consider "Mission and service in the parish."

We started after dinner with a talk by the Archdeacon of London, the Venerable Martin Sullivan, who in this excellent introduction to our weekend made the following points: —

- (1) We must realise that we can in no way separate what we sometimes call the secular from what we sometimes call the religious. Jesus was very much a man, who really suffered and died. God must not be separated from our life on earth. If we are going to understand the "religious" world it must be interpreted in the world in which we live.
- (2) The Laos (insufficiently interpreted as the Laity) must not be split into groups. The Laos are the people of God; all of us comprise the Laos, including the Vicar and our bishops. How can the ministry of the church be left to a few full time agents? We all, as the people of God, have responsibility in this.
- (3) Let us all strive to make ourselves better informed about our beliefs and increase our understanding of great Christian truths. Let us all read our Bibles more, but whatever we do let us not leave this land barren and infertile. We may be able to achieve this by meeting in small house groups for short periods of discussion and study.
- (4) If we want lively services then it is up to each one of us to contribute more to the service. Dreary services result from dreary congregations. Do we all sing? Do we all make a lively contribution? Or do we sit there and look religious?
- (5) We must as the people of God care and offer our services to the people in our parish. We must bring the love of Christ in somewhere. Perhaps into the world of commerce, politics, industry, or wherever we have the opportunity and wherever there is a need. The whole of Saturday was devoted to two topics
 - (1) Service in the Parish
 - (2) Mission in the Parish

and our ideas may be summarised within the following questions.

What is service? It is an appreciation that there are needs in the community; that we have our parts to play and are willing to perform them. It implies a love of God and a love of Man. Through love the needs of others may be pursued without any idea of reward. Though not a Christian monopoly it is a practical expression of Christianity.

We are not here concerned with a wider sense in which almost everyone qualifies as giving service to the community in some way and in balance gains his due reward as a member of the community.

How are these Community Needs being met in Our Parish? Some voluntary organisations giving free service are:— The Young Wives' Group, the Mothers' Union, the Old People's Welfare, the Choir, the Sunday Schools, the Y.P.F., the Parish Council and Church committees, the Hampton Hill Association, the Parent-Teachers' Association, Scouts and Guides, the Prayer Circle with spiritual activity. Many people work independently of organisations:— all who cheer the lonely; or break down the insularity of others; those who show friendliness without strings attached.

Is what we are doing effective? It is effective but insufficient. We could improve our effectiveness as follows:— Fill the need for further sick visiting; hospital visiting; visiting new people, new homes, closed communities, etc. Also to break down the class image of the Church by better mixing. We should operate a street-wardens scheme, and cooperate with the Old People's Welfare Committee in this.

What ought our Mission to be today? We should continue to spread the Gospel, i.e. bring God to the people; alternatively put, we should wean the people back to God. We should teach people to love and serve God and their neighbour as themselves. The power of God in dealing with individual and world problems is to be demonstrated. Modern conditions do not call for any change in the principles of mission, but in our methods we should move with the times.

How should we achieve our Mission? Full spiritual commitment is a prerequisite to mission. We need to get attuned to the minds and feelings of others. We need to set good examples as Christians, and display friendship both within the Church and outside. Our conversation should not hide the fact that we are christian.

On Sunday we considered everything that had previously been discussed and studied the following questions under the heading "The Parish Plans for Action."

(A) How can WE attain a spiritual deepening?

- (1) By increased bible study both individually and in groups but group study should be limited to short intense periods, such as a lenten course.
- (2) Personal discipline in prayer through a simple rule of life.
- (3) Seek our true vocations.
- (4) The congregation to make a real contribution in all services.
- (5) We should read christian books.
- (6) Encourage a wider membership of the Prayer Circle.

- (7) Obtain help and teaching about how to pray.
- (8) Hold quiet periods before meetings.
- (9) Get greater fellowship by meeting together at weekend courses and at Parish breakfasts, etc.

(B) Can we see a lack of unity in the Body of our Parish?

Yes! We can see disunity, but as we deepen our personal commitment to Christ and realise that we all have our parts to play in the Body of the Church any disunity will lessen and disappear.

(C) What are the next steps in Mission and Service in the Parish?

- (1) To form an assessment of resources and priorities, and to channel all help and ideas through the Stewardship Committee, with the M.R.I. Committee joining forces on specific tasks.
- (2) To introduce a road-warden scheme.
- (3) To send a personal letter to all newcomers as they arrive, indicating services, facilities and activities within the Parish; and to hold a special service from time to time to welcome them.
- (4) To instruct would-be helpers in methods of approaching the aged, the infirm, and the unbalanced.
- (5) Those who have discernible vocations, setting aside all modesty, to be invited to help in particular fields.
- (6) To encourage regular visiting of the lonely, widows, old people, and insulated families.
- (7) To rekindle the Church's power as a healing and caring Church through prayer.

The weekend was adjudged to have been a success and an event that could profitably be repeated. In further development we should perhaps guard against being too inward looking, and bear in mind the problems of the world at large. L.M.

THE ANNUAL CHURCH MEETING

AND PAROCHIAL CHURCH COUNCIL

The PCC have been giving much thought to its own composition and that of its committees. The problem centres round the procedure adopted hitherto whereby the six committees reporting to the PCC have been drawn fully from PCC members. This has resulted in both a rather large PCC and too little 'spread' on the committees. The field has been further narrowed by a poorly attended ACM.

This year, the ACM itself will be preceded by a social half hour during which attractive refreshment will be provided by the Social Committee. No official charge will be made, although a contribution plate will be suggestively positioned for those who would like to help towards the cost of their meal. To save time at the ACM itself, committee reports will not be given by the respective chairmen, but will be circulated previously. Questions on them will proceed as usual.

There may be big changes in election procedure, and an attempt to form committees with many non-PCC members on them.

One system suggested will, in future years, limit the PCC to its six officers and twelve other members in place of the present twenty-six. This year, however, the number must remain at twenty-six as constitutionally, no change can be made until next year, and then of course, only after ratification by this year's ACM. Assuming that agreement is reached, it will still be necessary to elect seven members 'over the top.'

Please turn up to the ACM. Too many willing people have not done so, through, it is felt, fear of being lumbered with more duties than time allows them. It is hoped that the proposed new system will remove these forebodings.

CHRISTIAN AID

On Wednesday, March 16, at 8 p.m., the Teddington Choral Society will give a performance at All Saints' Church, The Avenue, Hampton (Conductor: Mrs. Lisette Brooks). The soloists will be Jean Middleton, Irene Brayham, Kenneth Evans and Harvey Rathbone, with Jeffrey Bowyer, F.R.C.O., at the organ. The programme will consist of Faure's Requiem and Parry's Blest Pair of Sirens, with excerpts from Bach, Handel and Mendelssohn.

The society is well-known in the Thames Valley and further afield for its charity concerts of light music, and for its performances of religious works in churches and chapels of many denominations. On this occasion the proceeds will be given to CHRISTIAN AID and for this reason the concert should have a special appeal to all lovers of church music in Hampton and around. J.W.
